Treasurer's Report

Debra Graham '88 delivered the Treasurer's Report. Debra shared that the AHCCS&T no longer has a treasury, as the HAA covers the cost of the Annual Meeting. Additionally, she highlighted the value of the Partnered Treasury Program, in which 55 classes currently participate. She encouraged any classes that still have external treasuries to consider coming internal for the following reasons:

- Treasurers maintain their authority to decide how class funds are spent
- Treasurers no longer have to be responsible for tax filings
- The HAA manages the payment of any bills you may incur from your treasury for prereunion or non-reunion year events
- The HAA can provide more support for classes who want to host pre-reunion or off-cycle events
- Creates continuity in access to the funds should a treasurer no longer be able to serve in the role

If a class isn't going to bring their treasury internal, she asked that those treasurers include in their annual treasurer's report to HAA the name of a successor treasurer and the name of a cosignatory on your bank account. Mission Statement

Brad shared the proposed mission statement for AHCCS&T. There were some minor proposed changes, so the Executive Committee will adapt the statement and re-share it for ratification by the AHCCS&T membership. The goal in creating this mission statement is to better define the work of the Association:

The mission of the Association of Harvard College Class Secretaries & Treasurers is to foster communities of Harvard alumni by educating and supporting class secretaries and treasurers on growing class engagement, promoting inclusivity and belonging, and sharing information and resources for the benefit of the classes they represent and the University as a whole.

Brad opened the floor to new business. No new business was raised, and the business portion of the meeting was adjourned.
